



Water Rates

Water Rate, Other Charges and Billing Cycle

The following rates and charges are hereby fixed and established as the rates and charges to be collected by the Company for water services furnished by the Company to shareholders or authorized users of record.

The water bill consists of a monthly service charge, a water unit consumption charge, and a catastrophic loss fund charge (CLF) plus any miscellaneous charges that might be assessed to the account. Water consumption is measured in cubic feet. Each water unit represents 100 cubic feet or 748 gallons.

Water Rates

In 2010 Lincoln Avenue Water Company adopted a new Four Tier Water Rate Structure to promote water conservation.

New 4 Tier Water Rate Structure for One Share of Stock

If you are a multiple stockholder in Lincoln Avenue (own more than 1 share of stock) you will be allotted additional water units at the Tier I rate based on the number of shares owned up to a maximum 10 shares.

Shareholders with 2 shares will receive 14 units at the Tier I rate.

Shareholders with 3 shares will receive 21 units at the Tier I rate. Etc...

Billing Cycle

Your water meter is read between the 12th and 15th of each month. The bill is prepared and mailed to you on the last business day of each month.
